**Boss Revolution Call and Win Sweepstakes
(April 2017)**

OFFICIAL RULES

PLEASE READ THESE OFFICIAL RULES CAREFULLY. BY ENTERING THE SWEEPSTAKES, YOU UNCONDITIONALLY AGREE TO AND ACCEPT THESE RULES. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. OPEN TO LEGAL RESIDENTS OF THE UNITED STATES AGES 18 AND OLDER. THE SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.

1. **DATES.** The Sweepstakes will start on or about April 1, 2017 and will end on April 30, 2017.
2. **ELIGIBILITY.** The Sweepstakes is open only to legal residents of the United States 18 years of age or older. THE SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. The Sweepstakes is being operated only in the United States.

The following persons are not eligible to win or participate in the Sweepstakes: (a) employees, officers, directors and agents of IDT Domestic Telecom, Inc. No mechanically reproduced or photocopied requests allowed.

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A purchase will NOT improve your chances of winning. You may enter the Sweepstakes as often as you like subject to these Official Rules. All properly received entries will be entered into the Sweepstakes.

Boss Revolution pinless calling service is a prepaid calling service that allows users to make U.S. domestic and international calls. See www.bossrevolution.com for terms and conditions. Approximated value: \$50
